The UNDERSIGNED hereby represent and warrant that they are the parent(s) or legal guardian(s) of the Minor Contestant named above and they have full power, authority, capacity and right, without limitation, to execute, deliver and perform this Release.

Request to Participant. The UNDERSIGNED hereby request that the Minor Contestant be granted permission to enter the restricted areas and participate as a contestant in the MUTTON BUSTIN' competition (hereinafter referred to as "Event").

Consideration. In consideration of Minor Contestant being allowed to participate in the Event, the UNDERSIGNED hereby agree to the terms of this Contestant Waiver and Release Form.

Acknowledgement of Risk. The UNDERSIGNED understands and acknowledges that rodeos and related livestock events are dangerous activities and that participation in a rodeo or related livestock event exposes the participant to a substantial and serious hazzard which may result in property damage and/or personal injury or death. The UNDERSIGNED expressly acknowledge that the participation of the above named Minor Contestant will expose the Minor Contestant to such hazzards.

Release of Sponsor. The UNDERSIGNED, being fully aware that participation by the above named Minor Contestant in the Event will expose the Minor Contestant to a substantial and serious risk of property damage and/or personal injury or death, hereby releases the sponsors and the North Central Washington Fair & Big Bend Roundup Rodeo (hereinafter "RELEASEES"), from liability, and waives the right to sue, for any and all property damage and/or personal injuries or death, or other claims arising from the above named Minor Contestant's participation in the Event, even if the property damage and/or personal injury or death is determined to have resulted from the negligent acts or omissions of the RELEASEES.

Covenant Not to Sue. The UNDERSIGNED covenant that they shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceedings against RELEASEES, their officers, directors, employees, agents, assigns or affiliates for damages of any time arising from the participation of the above named Minor Contestant in the Event, whether such claims be for the benefit of the UNDERSIGNED or of the Minor Contestant.

Idemnificaiton. To the fullest extent permitted by law, the UNDERSIGNED hereby agree to defend and indemnify and to hold RELEASEES harmless from any liability, claims, demands, causes of action, loss and/or damage arising from participation of the above named Minor Contestant in the Event, even if caused by the negligent act or omissions of any of the RELEASEE(S).

North Central Washington Fair reserves the right to use any and all photographs taken during this event for publicity.
